CONDITIONS OF SUPERVISION FOR THE ADULT SEX OFFENDER PROGRAM

It is the finding of the court that:

→ Joined with 16CR3005 and 16CR3006

- Due to the nature and circumstances of the offense, regular probation supervision would not provide the necessary protection of the public, would deprecate the seriousness of the offender's conduct and would be inconsistent with the ends of justice.

- In compliance with 730 ILCS 150/3, the defendant shall register with the local police department within 3 days.
- In compliance with 730 ILCS 5/5-4-3, the defendant shall undergo DNA testing within _____ days.

The defendant:

- Shall attend and actively participate in sex offender treatment at a court-approved counseling program, follow all treatment providers' recommendations and be responsible for full/partial payment of treatment.
- Shall submit to polygraph examinations at the direction of the probation officer and/or counselor, to assist in treatment planning and case monitoring.
- Shall be prohibited from using alcohol and submit to breath and/or urine specimen analysis for the presence of a prohibited drug and/or alcohol at any time such requests are made by the probation officer.
- Shall not maintain a P.O. Box address while on probation.
- Shall not reside, initiate, establish or maintain contact with victim or any minor child, excluding including his/her children, under the age of 18, nor attempt to do so except under circumstances approved in advance and in writing by the court.
Defendant shall reside with his one (1) biological child.
- Shall not enter the premises, loiter, work or reside within 500 feet of school yards, parks, playgrounds, arcades, daycare, library, theme parks, carnival, toy stores, zoo or other places primarily used by children under the age of 18.
- Shall not accept employment or volunteer work, which will bring him/her in direct contact with minor children without permission from the court.
- Shall not have internet access except under circumstances approved in advance and in writing by the court.
- Shall not be in the possession of, or have in his/her residence, any pornography, erotica, and/or sexually explicit materials, visual and/or audio, and shall not access any pornography, erotica or sexually explicit services/materials via the telephone or internet.
- Shall submit to searches of his/her person, residence, papers, automobile and/or effects at any time such requests are made by the probation officer and shall consent to the use of anything seized as evidence in a court proceeding.
- Shall not enter or loiter around any adult bookstores or entertainment facilities where sexually explicit materials are sold or shown.
- Shall comply with a curfew established by the ADULT PROBATION DEPARTMENT for the duration of the probation.
- Shall notify third parties of the risks that may be occasioned by his/her criminal record or personal history or characteristics, and shall permit the probation officers to make such notifications and to confirm compliance with such notification requirement.
