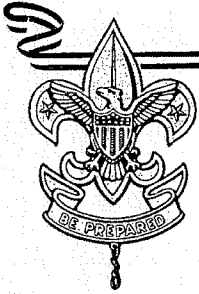

Dear Basil:


We regret to inform you that Scoutmaster Charles J. Grover, R.R.#2, Trenton 20, N. J., of Troop 95, Yardville Civic Association, Yardville, N. J., should be listed in the Confidential File. In a meeting of the full Troop Committee held last Friday night, July 7, the father of one of the Scouts described how his son was molested by Mr. Grover, and how several other Scouts had confirmed that Grover took his boy into bed with him at a camporee, and molested him.

Mr. Grover was at the meeting, and neither denied nor affirmed his conduct. He merely stated "I don't remember." This is an especially sad case, because Charley had been known to all the committee for many years, was very much liked by them and respected by them as an excellent Scoutmaster. This is a very good troop, with full participation by the committee. It is also sad to note that Mr. Grover's fiancée was killed in a tragic auto accident a year ago.

This man is 31 years old, thinning reddish hair, wiry build, about five feet seven inches tall, a little bowlegged, fair to reddish skin with freckles. Is an excellent mechanic, and operates his own garage. Hands are rough and obviously mechanic's.
