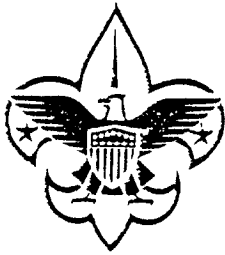

## Priest admits fondling boys

A Catholic priest admitted yesterday that he fondled two boys in the bedroom of their Sussex County home while wrestling with them in 1984.

The Rev. William Cramer, formerly at Our Lady of the Lake Church in Sparta, pleaded guilty to two counts of endangering the welfare of the children in Superior Court in Newton before Judge Jacques Gascoyne.

Cramer was indicted on charges of sexually assaulting an 11-year-old boy and having criminal sexual contact with a 14-year-old boy.

Although Cramer acknowledged placing a hand in the boys' groin areas, Sussex County Assistant Prosecutor Michael Briegel said the state's account would have been different if the case had gone to trial.

Defense attorney William McGovern said a plea was tendered because the case has been pending for a long time.

Sentencing was set for July 29.

The priest, who is in his early 40s, took a voluntary leave of absence from his work when the indictment was handed up, according to McGovern.

"He'll be going back. Once a priest, always a priest," McGovern said. Cramer lives with his mother in Morris County, he added.
